## **2. SUPPORT PARENTAL NOTIFICATION OF ABORTION**

**Barack Obama opposes notifying parents before an abortion can be performed on their minor daughters, and has voted against protecting states' parental notification laws**

In 2001 when he was an Illinois state senator, Obama declined to take a position on two pieces of legislation that would have required parental notification for minors who have an abortion, voting "present" instead of "yes" or "no." But five years earlier, he had filled out an issues questionnaire for the influential Independent Voters of Illinois Independent Precinct Organization opposing such notifications. "Do you support parent consent/notification for minors seeking abortion?" the survey asked. "No," he wrote. Obama also answered that he supported Medicaid funding and state worker insurance coverage for abortion and that he didn't support "any other" restrictions on the procedure.

STEPHANOPOULOS: What is your position on gay adoption? You told the "New York Times" you were against it, even in cases where the children couldn't find another home. But then your staff backtracked a bit. What is your position?

MCCAIN: My position is, it's not the reason why I'm running for president of the United States. And I think that two parent families are best for America.

STEPHANOPOULOS: Well, what do you mean by that, it's not the reason you're running for president of the United States?

MCCAIN: Because I think -- well, I think that it's -- it is important for us to emphasize family values. But I think it's very important that we understand that we have other challenges, too. I'm running for president of the United States, because I want to help with family values. And I think that family values are important, when we have two parent -- families that are of parents that are the traditional family.

STEPHANOPOULOS: But there are several hundred thousand children in the country who don't have a home. And if a gay couple wants to adopt them, what's wrong with that?

MCCAIN: I am for the values that two parent families, the traditional family represents.

STEPHANOPOULOS: So, you're against gay adoption.

MCCAIN: I am for the values and principles that two parent families represent. And I also do point out that many of these decisions are made by the states, as we all know. And I will do everything I can to encourage adoption, to encourage all of the things that keeps families together, including educational opportunities, including a better economy, job creation. ## **6. ALLOW LOCAL GOVERNMENTS TO BAN GUN OWNERSHIP**

### **Until this year's ruling by the U.S. Supreme Court, Barack Obama supported allowing local governments to ban gun ownership**

Major Garrett: But before the high court's decision, Obama's campaign tried to suggest the presumptive Democratic nominee didn't really support the D.C. handgun ban. But this February interview showed otherwise.

Local TV host: But you support the D.C. handgun ban [Obama: "Right"]

and you said that it's constitutional [Obama: "Right"], how can you reconcile those two different positions?

Major Garrett: In answering a 1996 questionnaire, Obama said he supported an all-out ban on the manufacture and sale of handguns, an answer that the campaign now attributes to a misinformed aide. In 2004, Obama voted in the Illinois legislature against shielding anyone who used a handgun in self defense from being prosecuted under local ordinances banning possession of a handgun.

And we need somebody who's got the heart—the empathy—to recognize what it's like to be a young teenage mom. ## **Barack Obama has pledged to increase taxes and to eliminate existing tax cuts**

Q: McCain is going to say you're going to raise taxes.

A: I will raise CEO taxes. There is no doubt about it.

Q: What about the average American?

A: If you are a CEO in this country, you will probably pay more taxes. They won't be prohibitively high. You're going to be paying roughly what you paid in the '90s, when CEOs were doing just fine.

Q: So, you want to just eliminate the Bush tax cuts?

A: I want to eliminate the Bush tax cuts. And what I have said is, I will institute a middle-class tax cut. So, if you're making \$75,000, if you're making \$50,000 a year, you will see an extra \$1,000 a year offsetting on your payroll tax.

Both John McCain and Barack Obama have proposed tax plans that would substantially increase the national debt over the next ten years, according to a newly updated analysis by the non-partisan Tax Policy Center. Compared to current law, TPC estimates the Obama plan would cut taxes by \$2.9 trillion from 2009-2018. McCain would reduce taxes by nearly \$4.2 trillion. Obama would give larger tax cuts to low- and moderate-income households and pay some of the cost by raising taxes on high-income taxpayers. In contrast, McCain would cut taxes across the board and give the biggest cuts to the highest-income households.

Under Obama's plan, the highest corporate tax tier would hold at 35% -- a nod to Wall Street but higher than McCain's slashed rate. Obama would raise the highest rate on dividends and capital gains from 15% to 20%. And he would keep the estate tax in the same form approved by Congress for 2009, with an exemption for the first \$3.5 million and a top tax rate of 45%. That would mean a higher tax rate on the wealthy than McCain would allow.

## **John McCain has pledged to veto any tax increase and says he supports making existing tax cuts permanent**

WALLACE: ... on these hot-button issues involving quick questions, quick answers. As president, will you veto any tax increase passed by a Democratic Congress?

MCCAIN: Yes.

WALLACE: That's quick, but — and in fact, I think...

MCCAIN: Well, I think the worst thing we can do right now, Chris, is — we've got some shaky economic times — is to increase people's taxes. And I think that what we need is more tax cuts. We need to make Bush tax cuts permanent. We need to get rid of the ATM. Corporate taxes in America are the second highest in the world. We need to cut corporate taxes. We need to give people reasons to write off and depreciate their business investments and equipment investments. We need to stop the pork barrel spending. Look, the president signed into law two major spending bills that had \$35 billion worth of earmark projects. And if we had taken that money, we could have given a \$1,000 tax credit for every child in America. This is big money. Everybody says, "Oh, it really isn't that much." It's a lot. And even more importantly than that, it has totally eroded the confidence of the American people about what we do with their tax dollars.

"We're also going to keep the low rate on capital gains, so that businesses like yours can expand and create jobs instead of just sending more of your earnings to the government. “My record is very clear. I have never voted for a tax increase in 24 years. That should be sufficient time to convince average Americans of my commitment not to raise taxes.”... McCain now says that his votes against the Bush tax cuts in 2001 and 2003 arose from a disagreement about what kind of tax cuts were needed. McCain later supported a 2006 extension of some of the Bush cuts, and says he now thinks all the cuts should be extended when most of them expire in 2010. This has not been enough to mollify some conservative critics, including the Club for Growth, which called McCain's overall record on taxes “profoundly disturbing and anti-growth.” The club’s president, Pat Toomey, said he is particularly upset by a 1998 vote by McCain to increase cigarette taxes.

Americans for Tax Reform President Grover Norquist noted that the 1998 tobacco bill was made less objectionable by its limitations on fees for lawyers suing the industry. He said that consumers hit with the new taxes would also ultimately have benefited from the lower payments being made to the attorneys. Norquist said he was “comfortable” with McCain’s repeated assertions that he will not raise taxes. A spokeswoman for the Club for Growth said its president, former Rep. Pat Toomey (R-Pa.), views the tobacco bill as a “drop in the bucket.” He too has accepted McCain’s promise not to raise taxes.
